## **Tiong Woon seals deals with Shell for 3 projects for provision of mobile cranes and maintenance works; continues organic growth trend in Heavy Lift & Haulage**

**SINGAPORE, 29 September 2009 – MAINBOARD-LISTED Tiong Woon Corporation Holding Ltd** (Tiong Woon or TWC) begins fiscal year 2010 on a strong note by announcing today that its wholly-owned subsidiary, Tiong Woon Crane Pte Ltd, has been awarded two contracts by Shell Eastern Petroleum (Pte) Ltd (SEPL) and Shell Chemicals Seraya (Pte) Ltd (SCSL) for the provision of mobile cranes and lifting services to the mono-ethylene glycol (MEG) plant and the Seraya plant on Jurong Island respectively. At the same time, Tiong Woon Crane Pte Ltd was also awarded another contract by SEPL to provide safe and proper lifting and transport services for the Shell Bukom plant. For confidentiality reasons, Tiong Woon is unable to disclose the contract amounts.

The first contract shall be for a period of five (5) years beginning on 1 January next year and ending on 31 December 2014, with an option to extend for a further period of no more than five (5) years. The second project shall also be for five (5) years covering the same period. The third deal is targeted to start on 1 October and end on 30 September 2014 and comes with an option for a further two-year extension.

TWC is an integrated services provider for the Oil & Gas and Petrochemicals sectors and specialises in heavy lift and installation of process equipments. The Company is ranked the 21<sup>st</sup> largest crane owning company worldwide by International Cranes, a reputable trade magazine, in its IC50 2009 survey.

Mr. Ang Kah Hong, Tiong Woon's Group Chairman and Managing Director, was delighted with the three contract wins. He said, "Shell has been a valued customer and we are delighted to be associated with such a strong and reputable name." Mr Ang said that the Group's Heavy Lift and Haulage segment will continue to see the strong organic growth it has been experiencing.

Commenting on the maintenance contract, Mr Ang said, "Maintenance works bring in an important recurring revenue stream for Tiong Woon and keeps the business going. Our best practices employed in all our maintenance projects improve the reliability and performance of our customers' production facilities, increasing efficiency and thereby reducing costs in their plants so that our clients can concentrate on running their businesses. We are very pleased to have secured yet another maintenance contract from a valuable client. Our team looks forward to starting work and we will do our best to meet all the requirements of the project."

These contract wins follow a strong Group performance for fiscal 2009. For the year ended 30 June 2009, the Group recorded its highest ever net profit after tax and minority interest of S\$42.3 million on a record turnover of S\$202.3 million, due mostly to higher contributions from its Heavy Lift and Haulage and Fabrication and Engineering segments.
